Fixed Term Deposit Accounts

The interest rate applicable to early redemptions of fixed term deposits will be the comparable rate for the resultant term applicable at the date of investment minus 1.00%.

30 Day Notice of Withdrawal Account (\$8)

The \$6 on call rate of interest is payable on all or part of the deposit amount redeemed if less than 30 days notice of withdrawal is given.

Christmas Club Account (\$2)

Three withdrawals available from 1st January to the 31st October each incurring a \$5.00 fee. The fourth withdrawal will result in the account being closed.
